



**Genetically Modified Organisms (GMO) Information

Based upon information provided by our raw material suppliers, crude and semi-refined oils as supplied and used by California Oils Corporation to produce various edible oil products of palm, palm kernel, and coconut origin are not a product of transgenic or recombinant DNA technology, commonly referred to as Genetically Modified Organisms (GMO).

While California Oils Corporation does not control nor monitor the specific processes, we are informed that the associated trees are produced through traditionally accepted plant breeding and harvesting methodologies.

Our refined, bleached, deodorized (RBD) products have a small amount of citric acid added at the time of deodorization for the purpose of metal ion sequestration. This product is produced by a fermentation process employing non-GMO strains of *Aspergillus niger*. The product has been verified by the manufacturer to be free of modified DNA and/or the proteins associated therewith by PCR testing. No enzymes are used in any of our processes.

Products containing customer-requested additives and their associated raw materials and/or carriers may or may not be derived from sources of genetically modified organisms. Vendor specific information relating to the status of that additive can be provided. California Oils Corporation may source from multiple vendors.




